President Bob Hunt stated that we need articles on the Foundation to save our mailing permit. He reminded all Trustees that they need to submit an articles about the Foundation - to date only 3 Trustees have sent anything in.

<u>Auction</u> - Trustee Earl Sawyer stated there would not be a 'silent auction' at this meeting, because the turnout may be small and is too close to after Christmas. He reminded all Trustees to let him or Jim Hall know what articles they have collected for the Des Moines auction.
