UNITED STATES JCI SENATE FOUNDATION MINUTES OF THE ANNUAL TRUSTEES MEETING LOUISVILLE, KENTUCKY JUNE 12, 1990

A quorum being present, the meeting was called to order by President William Miller at 7:30 A.M.

Trustees present were President William Miller, Vice President Doug Hincker, Treasurer Steve Pindell, Secretary Jim Hall, Trustee M.S. "Doc" McCarty, Trustee Tony Dominiec, and Trustee Caleb Fraser. Trustee Jack Myers was excused.

There were 11 non-Trustee guests also present.

Secretary James A. Hall moved that minutes for the Gatlinburg meeting be approved as mailed. The motion was seconded by Trustee Tony Dominiec and approved by the Trustees. Secretary Hall then moved that the minutes of the Annual Meeting held in Memphis, Tennessee, June 1989 be approved as mailed. Trustee Fraser seconded. The motion was approved by the Trustees.

Treasurer Steve Pindell presented an interim Financial Statement showing operations from July 1, 1989 through June 8, 1990. It was moved by Trustee Hincker, seconded by Trustee McCarty, that the interim financial statement be approved as presented. Motion carried.

Treasurer Pindell then discussed year end closing, advising that our fifth year of operations as a Foundation had passed and that a year end financial statement and a copy of the IRS filing would be in our accounting hands by early August 1990.

Vice President Douglas Hincker gave a report on the Scholarship Program. He advised that applications for scholarships numbered 407, had gone through preliminary judging, and the final selections committee was to meet in 10 days—allowing winners to be announced by June 30, 1990.

Trustee Marvin S. McCarty gave a presentation on the Levels of Giving Program and a report on the cocktail reception held Monday evening, advising the Trustees that the reception had been privately funded this year.
